### **2026 EVENT DESCRIPTION**

- **The parade is Thursday, November 19, 2026 Entry lineup is at 5 p.m. The parade begins at 6:30 p.m.**
- The parade route runs from West 2nd Street down Central Avenue South to 9th Street.
- Float positions are lined up *as you come* with the exception of a) event sponsors being at the front of the parade and b) those bringing live animals. A volunteer team coordinates entrance from Veteran's Parkway into the City of Marshfield garage parking lot.
- This event exists to provide holiday cheer to Marshfield and its visitors, provide an opportunity to showcase Marshfield's area businesses in the parade, and also to bring awareness and drive sales downtown. The event is organized by local non-profit Main Street Marshfield (Main Street). Main Street's organizational mission is to energize and strengthen downtown Marshfield.

### **PARADE ENTRY POLICIES**

- **Every parade entry must be illuminated! Really illuminated.** This is a parade of light, so even if you are driving a single vehicle without a float, you'll need to decorate.
- No entry may have a Santa Claus. St. Nick will arrive at the end of the parade on the Main Street float.
- Santa is the only celebrity in this parade. We do not allow political advertising or queen candidates, etc.
- If it does not delight a small child's eyes it is not an appropriate entry for this parade.
- Entries may have the name of sponsors only – no additional advertising or endorsement is allowed.
- Keep things moving. One stopped float throws the entire event off pace. Keep 50 feet between you and the next float at all times.
- Radio stations, do your best to consolidate to 1 or 2 cars if you have 3 or more stations from your networks being represented in the parade.

- Your parade entry form accompanied by proof of insurance or a signed hold harmless agreement must be approved through the Main Street Marshfield office in order to participate in the parade. The application deadline is **November 1st, 2026.**
